# Tuggeranong Archery Club Inc.

## Access and Membership Policy

### Signing In

- All members must swipe their security tag to enter the range or sign the sign-on sheet every time they are at the range regardless of whether they are shooting.
- All members' guests and visitors must be signed in by the responsible member.

### Smoking

- Designated smoking area is the club car park.
- Smoking is prohibited on the club grounds and archery range(s).

### Parking

- Vehicles are to be parked in the car park area.
- Vehicles may be driven into the TAC range area(s) when being used for club and maintenance activities.
- Disabled parking spaces are available next to the main access gate.
- Under no circumstances are vehicles to be driven or parked on the paved shooting areas.

### Range Fees

- Members who have not pre-paid range fees must pay the exact range fee at the commencement of each range session.
- Members who prepay range fees are entitled to purchase a Security tag and range key.
- All members should ensure others do not abuse the system by not paying their range fees.

### Field Range Flag

- TAC field range(s) is only available to members who have pre-paid range fees and have their own range key.
- Members who have not pre-paid their range fees may only use the TAC field range(s) on published field open days.
- Members who use the TAC field range(s) must display the field flag on the main gate.

### Key Policy

- Keys and security tags will only be issued to full or Affiliated TAC members who have pre-paid their range fees.
- Current holders of keys who have not paid range fees by their anniversary date each year must return their key(s).
- The club reserves the right to change the locks at any time and will notify all members of that change – where upon old keys must be surrendered in exchange for new keys.
- Anyone abusing the access to the range will have their rights and key access withdrawn and will surrender their key(s) upon a written request on behalf of the committee.

### **Membership categories as per the Tuggeranong Archery Club (TAC) Constitution –**

- *full member* means a member who is a member of Archery Australia Inc. by virtue of their membership of TAC.
- *life member* means a member who has the same rights and responsibilities as a full member and due to his life membership does not pay club membership or shooting fees, normal AA and AACT fees still apply.
- *associate member means a member who is a non-shooting member of the club and is therefore* not required to be a member of Archery Australia Inc.
- *junior membership* means full members under 20 years of age who have consent and are supervised by their legal guardian.
- *family membership* means full members in a household group consisting of either one or both adults (20 years and older) and their dependant(s) who are juniors (under 20 years of age).
- *affiliated member* means a member who is a member of Archery Australia Inc. by virtue of their membership of another association.
- *affiliated member (group)* means any organisation which, as a group, agrees with the aims of the Association is eligible for Affiliate Membership. Affiliate Membership is available for one calendar year upon payment of a fee as determined by the Committee.

### **Range Access for different membership types –**

#### Associate members

- Associate members are not permitted to use any of the TAC range(s).
- Associate members are able to accompany full members and junior members onto the range(s).

#### Junior members

- Junior members are to be accompanied on the range by a full member or an adult responsible associate member.
- Associate members may accompany full members and junior members.

#### Affiliated members

- Affiliated members shall apply for membership of TAC in accordance with the Constitution.
- Affiliate members may not vote or be a club office holder.
- Membership fees are the equivalent of the full yearly TAC membership fee.

#### Affiliated members (Group)

- Affiliated group members must carry their current group membership details when using the range.
- In accordance with the Constitution, members of affiliated groups may not vote or hold any club office.
